RULES

Deadline:

The contest runs until 24:00 September 10, 2021. All submissions must be received by this date. The Government of Newfoundland and Labrador, nor its departments, are responsible for entries that are lost, late, delayed, misdirected, unintelligible, illegible, incomplete, ineligible, separated, or undeliverable entries.

Eligibility:

The Photo Contest is open to legal residents of Canada, excluding Quebec, who have reached the legal age of majority in their province/territory of residence at the time of entry, except employees of Newfoundland and Labrador Parks Division and/or their immediate family members.

Entry:

- All contest entries must include a completed Entry Form.
- The number of entries is limited to 10 photographs per person. Each photograph must include a separate Entry Form.

Categories:

Photographs submitted to the contest should represent this year's theme which is "Friends and Family".

To qualify for entry, photographs should include:

- Image(s) of two or more people enjoying a Provincial Park (Camping; Day Use; Waterway; T'Railway: https://www.parksnl.ca/parks/)
- Image of individuals participating in activities such as camping, hiking, kayaking, canoeing, picnicking, swimming, enjoying nature, etc.

Prizes:

- The winners of the top three photos will receive a Seasonal Vehicle Entry Pass to Newfoundland and Labrador Provincial Parks (\$50 value).
- There will also be two (2) random draws that all applicants will be entered in for a Seasonal Vehicle Entry Pass to Newfoundland and Labrador Provincial Parks (\$50 value).

one grand prize will be awarded from category winners. The grand prize includes 7 nights of camping in a Newfoundland and Labrador Provincial Park of the winners choosing, and is limited to park availability of the chosen nights (valued at \$123.59 for unserviced and \$190.76 for serviced). The camping nights are nontransferable and must be used by the winner in the 2022 camping season.

Photo and File Requirements:

Acceptable entries must be in digital format, high resolution (horizontal format preferred), and entries must be submitted through the contest email address **info@parksnl.ca**. The file resolution must be a minimum of 300 dpi 600x800. Compositional changes to digital files are not acceptable and will be disqualified; tonal or colour cast corrections are acceptable. For all entries, original capture file must be available at request for reproduction purposes. All entries and contest materials received become the property of the contest organizers.

Any photos containing identifiable people must also be accompanied by a "Model Release Form" for each identifiable person. Model releases are the responsibility of the entrant.

All photos must be of legal activities, taking into consideration safety, if applicable (photos of cyclists must be wearing helmets, life jackets on boaters etc.) and the legislation governing Provincial Parks.

To be considered in the contest, all submissions must be original, unpublished photographs taken of or in a Newfoundland and Labrador Provincial Park. The list of Provincial Parks can be found under the 'Naming Guidelines' section at the end of this document.

Entry Form Agreement:

By signing the Entry Form, the entrant grants the Parks Division, and the Government of Newfoundland and Labrador a nonexclusive, worldwide irrevocable, royalty-free license to reproduce, distribute, use in publications and presentations, reuse, alter, modify, crop, publicly display all photographs submitted. Parks Division is not obligated to use photographer's name as a credit along with the photograph. The photographer must own all rights to any photographs entered in this contest. It is the

responsibility of the entrant to ensure that publication of the photographs raises no legal claims. Accordingly, you hereby agree to compensate the sponsors fully regarding any claims arising out of the use of your photograph(s). Photograph(s) previously published in full or in part in other publications, contests etc., will be disqualified.
